Pursuant to Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), (OJ EU L 119, 4.5.2016, p. 1), hereinafter referred to as "GDPR":

## Purposes of and legal bases for the processing

Your personal data will be processed pursuant to Article 6(1)(c) GDPR and Article 4(2)(2) of the Parliament Guard Act of 26 January 2018 (Journal of Laws of 2023, item 1729) in conjunction with Article 2(1)(3) and Article 4(1) of that Act, in order to provide access to buildings and areas under the protection of the Parliament Guard, and to provide content-related and organisational support for the event. Providing personal data is voluntary; however, if you do not provide this data, you will not be able to access buildings and areas protected by the Parliament Guard. This will prevent you from participating in events held in those areas.

Your personal data will be processed pursuant to Article 6(1)(e) GDPR – processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller, in order to organise the event and for your participation in the event; in that case, your personal data will be made available to other participants of the event and will be published on the website of the parliamentary dimension of the Polish Presidency of the EU Council.

Your personal data will be processed pursuant to Article 6(1)(a) GDPR in order to promote the event. The joint controllers may make your personal data available on the YouTube channel and the official profiles of the Chancellery of the Sejm and/or

the Chancellery of the Senate, including in social media, such as X (formerly Twitter), Meta Platforms (Facebook and Instagram), and Flickr.

## **Recipients of personal data**

## Data storage period

Your personal data will be stored for the period necessary to fulfil the purposes of the processing, not less than the period specified in the archiving legislation.

# Data subjects

You have the following rights:

- the right to access and the right to rectify your personal data;
- to the extent provided by law the right to erasure and the right to restrict the processing of your personal data, although separate provisions may exclude the exercise of this right;
- in the case of processing under your consent, you have the right to withdraw your consent to the processing of your personal data, but the consent

withdrawal shall not affect the lawfulness of the processing carried out under the consent before its withdrawal;

• the right to lodge a complaint with the President of the Personal Data Protection Office, if you believe that the processing of your personal data violates the law.
